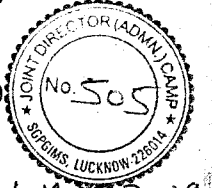


The tenure of the above committee will be for three years from the date of issue of this order.
