The Kamdhenu Ati Nirdhan Chikitsa Sahayata Society is an autonomous registered society (Registered under U.P. Societies Registration Act 1860, Registration No. 1268) was established in 24 August 1999 to provide financial assistance to the poor/needy patients who were attending the Sanjay Gandhi PGIMS for treatment.

The fund for this activity was provided by a grant of Rs. 1,00,00,000/- (Rupees One Crore only) by the U.P. Govt. through Institute. The above amount has been invested in a fixed deposit and the interest is disbursed towards financial assistance to the needy/poor patients of Institute. The corpus has been recently increased to Rs. 4.75 cores. The Society is run by a management committee consisting of Director, SGPGI, Lucknow, Retired High Court Judge Justice G.D. Malviya, Hon'ble Shri T.P. Tiwari ji, Ex. Governor of Pondicherry and Ex. Chief Secretary of U.P. and faculty members of the Institute.

Since its inception, more than 1260 patients have received financial assistance amounting to approximately Rs. 52 lack. We hope to give more money in 2007-08 and we have increased the amount to Rs. 20,000/- per patient from a figure of Rs. 10,000/- in the current year.

We shall greatly appreciate your generous grant so that we can provide assistance to more patients who come for their treatment for serious diseases to our tertiary care superspeciality institute.
